Item 4: Other Business Activities

Andrew Lawrence Zorovich is a licensed insurance agent with Infinity Largo, LLC. Infinity Largo, LLC and Infinity Investment Advisors LLC are under common ownership. This activity

creates a conflict of interest since there is an incentive to recommend insurance products based on commissions or other benefits received from the insurance company, rather than on the client's needs. Additionally, the offer and sale of insurance products by supervised persons of Infinity Investment Advisors LLC are not made in their capacity as a fiduciary, and products are limited to only those offered by certain insurance providers. Infinity Investment Advisors LLC addresses this conflict of interest by requiring its supervised persons to act in the best interest of the client at all times, including when acting as an insurance agent. Infinity Investment Advisors LLC periodically reviews recommendations by its supervised persons to assess whether they are based on an objective evaluation of each client's risk profile and investment objectives rather than on the receipt of any commissions or other benefits.
